



BEARFACTS 1991 – 2001

Hagerstown-Martinsburg (MSA) [25180]

Hagerstown-Martinsburg is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2001 population of 226,751 ranked 180th in the nation.

PER CAPITA PERSONAL INCOME

In 2001 Hagerstown-Martinsburg had a per capita personal income (PCPI) of \$25,756. This PCPI ranked 200th in the United States and was 84 percent of the national average, \$30,574. The 2001 PCPI reflected an increase of 5.6 percent from 2000. The 2000-2001 national change was 2.4 percent. In 1991 the PCPI of Hagerstown-Martinsburg was \$16,264 and ranked 269th in the United States. The 1991-2001 average annual growth rate of PCPI was 4.7 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Hagerstown-Martinsburg had a total personal income (TPI) of \$5,840,259*. This TPI ranked 183rd in the United States. In 1991 the TPI of Hagerstown-Martinsburg was \$3,223,631* and ranked 187th in the United States. The 2001 TPI reflected an increase of 7.1 percent from 2000. The 2000-2001 national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.1 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hagerstown-Martinsburg. In 2001 net earnings accounted for 68.1 percent of TPI (compared with 67.2 in 1991); dividends, interest, and rent were 15.8 percent (compared with 17.3 in 1991); and personal current transfer receipts were 16.1 percent (compared with 15.5 in 1991). From 2000 to 2001 net earnings increased 6.5 percent; dividends, interest, and rent increased 4.0 percent; and personal current transfer receipts increased 12.9 percent. From 1991 to 2001 net earnings increased on average 6.3 percent each year; dividends, interest, and rent increased on average 5.2 percent; and personal current transfer receipts increased on average 6.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hagerstown-Martinsburg increased from \$3,642,674* in 2000 to \$3,845,555* in 2001, an increase of 5.6 percent. The 2000-2001 national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$2,279,090* to the 2001 estimate was 5.4 percent. The average annual growth rate for the nation was 5.8 percent.
