



BEARFACTS 1991 – 2001

Muncie (MSA) [34620]

Muncie is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2001 population of 120,005 ranked 291st in the nation.

PER CAPITA PERSONAL INCOME

In 2001 Muncie had a per capita personal income (PCPI) of \$24,451. This PCPI ranked 260th in the United States and was 80 percent of the national average, \$30,574. The 2001 PCPI reflected an increase of 0.2 percent from 2000. The 2000-2001 national change was 2.4 percent. In 1991 the PCPI of Muncie was \$16,952 and ranked 217th in the United States. The 1991-2001 average annual growth rate of PCPI was 3.7 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Muncie had a total personal income (TPI) of \$2,934,206*. This TPI ranked 292nd in the United States. In 1991 the TPI of Muncie was \$2,033,813* and ranked 269th in the United States. The 2001 TPI reflected an increase of 1.2 percent from 2000. The 2000-2001 national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 3.7 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Muncie. In 2001 net earnings accounted for 63.9 percent of TPI (compared with 66.8 in 1991); dividends, interest, and rent were 18.4 percent (compared with 18.1 in 1991); and personal current transfer receipts were 17.7 percent (compared with 15.1 in 1991). From 2000 to 2001 net earnings decreased 1.7 percent; dividends, interest, and rent increased 3.7 percent; and personal current transfer receipts increased 10.4 percent. From 1991 to 2001 net earnings increased on average 3.3 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 5.4 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Muncie decreased from \$2,138,041* in 2000 to \$2,129,269* in 2001, a decrease of 0.4 percent. The 2000-2001 national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$1,530,265* to the 2001 estimate was 3.4 percent. The average annual growth rate for the nation was 5.8 percent.
