



BEARFACTS 1991 – 2001

Sebastian-Vero Beach (MSA) [42680]

Sebastian-Vero Beach is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2001 population of 115,334 ranked 298th in the nation.

PER CAPITA PERSONAL INCOME

In 2001 Sebastian-Vero Beach had a per capita personal income (PCPI) of \$39,470. This PCPI ranked 10th in the United States and was 129 percent of the national average, \$30,574. The 2001 PCPI reflected an increase of 6.4 percent from 2000. The 2000-2001 national change was 2.4 percent. In 1991 the PCPI of Sebastian-Vero Beach was \$25,921 and ranked 8th in the United States. The 1991-2001 average annual growth rate of PCPI was 4.3 percent. The average annual growth rate for the nation was 4.4 percent.

TOTAL PERSONAL INCOME

In 2001 Sebastian-Vero Beach had a total personal income (TPI) of \$4,552,238*. This TPI ranked 213th in the United States. In 1991 the TPI of Sebastian-Vero Beach was \$2,426,020* and ranked 231st in the United States. The 2001 TPI reflected an increase of 8.2 percent from 2000. The 2000-2001 national change was 3.5 percent. The 1991-2001 average annual growth rate of TPI was 6.5 percent. The average annual growth rate for the nation was 5.6 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Sebastian-Vero Beach. In 2001 net earnings accounted for 33.2 percent of TPI (compared with 36.3 in 1991); dividends, interest, and rent were 51.7 percent (compared with 49.1 in 1991); and personal current transfer receipts were 15.0 percent (compared with 14.6 in 1991). From 2000 to 2001 net earnings decreased 1.4 percent; dividends, interest, and rent increased 15.1 percent; and personal current transfer receipts increased 9.1 percent. From 1991 to 2001 net earnings increased on average 5.6 percent each year; dividends, interest, and rent increased on average 7.1 percent; and personal current transfer receipts increased on average 6.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Sebastian-Vero Beach decreased from \$1,722,698* in 2000 to \$1,708,697* in 2001, a decrease of 0.8 percent. The 2000-2001 national change was 3.1 percent. The average annual growth rate from the 1991 estimate of \$994,978* to the 2001 estimate was 5.6 percent. The average annual growth rate for the nation was 5.8 percent.
