



BEARFACTS 1992 – 2002

Ketchikan Gateway Borough , Alaska [02130]

Ketchikan Gateway Borough is one of 27 counties in Alaska. It is part of the Ketchikan, AK Micropolitan SA. Its 2002 population of 13,575 ranked 8th in the state.

PER CAPITA PERSONAL INCOME

In 2002 Ketchikan Gateway Borough had a per capita personal income (PCPI) of \$36,012. This PCPI ranked 4th in the state and was 112 percent of the state average, \$32,243, and 117 percent of the national average, \$30,821. The 2002 PCPI reflected a decrease of 1.8 percent from 2001. The 2001-2002 state change was 1.8 percent and the national change was 0.8 percent. In 1992 the PCPI of Ketchikan Gateway Borough was \$28,415 and ranked 3rd in the state. The 1992-2002 average annual growth rate of PCPI was 2.4 percent. The average annual growth rate for the state was 3.1 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Ketchikan Gateway Borough had a total personal income (TPI) of \$488,866*. This TPI ranked 6th in the state and accounted for 2.4 percent of the state total. In 1992 the TPI of Ketchikan Gateway Borough was \$412,391* and ranked 6th in the state. The 2002 TPI reflected a decrease of 3.2 percent from 2001. The 2001-2002 state change was 3.4 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 1.7 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Ketchikan Gateway Borough. In 2002 net earnings accounted for 66.1 percent of TPI (compared with 73.6 in 1992); dividends, interest, and rent were 17.5 percent (compared with 15.8 in 1992); and personal current transfer receipts were 16.5 percent (compared with 10.6 in 1992). From 2001 to 2002 net earnings decreased 4.4 percent; dividends, interest, and rent decreased 3.7 percent; and personal current transfer receipts increased 2.4 percent. From 1992 to 2002 net earnings increased on average 0.6 percent each year; dividends, interest, and rent increased on average 2.8 percent; and personal current transfer receipts increased on average 6.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Ketchikan Gateway Borough decreased from \$377,568* in 2001 to \$360,847* in 2002, a decrease of 4.4 percent. The 2001-2002 state change was 5.1 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$355,533* to the 2002 estimate was 0.1 percent. The average annual growth rate for the state was 3.4 percent and for the nation was 5.4 percent.
