



BEARFACTS 1992 – 2002

St. Lawrence , New York [36089]

St. Lawrence is one of 62 counties in New York. It is part of the Ogdensburg-Massena, NY Micropolitan SA. Its 2002 population of 110,623 ranked 26th in the state.

PER CAPITA PERSONAL INCOME

In 2002 St. Lawrence had a per capita personal income (PCPI) of \$20,394. This PCPI ranked 59th in the state and was 58 percent of the state average, \$35,416, and 66 percent of the national average, \$30,821. The 2002 PCPI reflected an increase of 0.5 percent from 2001. The 2001-2002 state change was -0.6 percent and the national change was 0.8 percent. In 1992 the PCPI of St. Lawrence was \$14,520 and ranked 60th in the state. The 1992-2002 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the state was 3.6 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 St. Lawrence had a total personal income (TPI) of \$2,256,026*. This TPI ranked 31st in the state and accounted for 0.3 percent of the state total. In 1992 the TPI of St. Lawrence was \$1,656,017* and ranked 32nd in the state. The 2002 TPI remained unchanged from 2001. The 2001-2002 state change was - 0.3 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 3.1 percent. The average annual growth rate for the state was 4.1 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of St. Lawrence. In 2002 net earnings accounted for 59.8 percent of TPI (compared with 62.8 in 1992); dividends, interest, and rent were 14.4 percent (compared with 16.1 in 1992); and personal current transfer receipts were 25.8 percent (compared with 21.1 in 1992). From 2001 to 2002 net earnings decreased 0.6 percent; dividends, interest, and rent decreased 9.0 percent; and personal current transfer receipts increased 7.5 percent. From 1992 to 2002 net earnings increased on average 2.6 percent each year; dividends, interest, and rent increased on average 2.0 percent; and personal current transfer receipts increased on average 5.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in St. Lawrence decreased from \$1,540,770* in 2001 to \$1,525,115* in 2002, a decrease of 1.0 percent. The 2001-2002 state change was - 0.3 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$1,196,693* to the 2002 estimate was 2.5 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.4 percent.
