



BEARFACTS 1992 – 2002

Rutherford , North Carolina [37161]

Rutherford is one of 100 counties in North Carolina. It is part of the Forest City, NC Micropolitan SA. Its 2002 population of 62,994 ranked 38th in the state.

PER CAPITA PERSONAL INCOME

In 2002 Rutherford had a per capita personal income (PCPI) of \$22,171. This PCPI ranked 64th in the state and was 81 percent of the state average, \$27,488, and 72 percent of the national average, \$30,821. The 2002 PCPI reflected an increase of 1.0 percent from 2001. The 2001-2002 state change was unchanged national change was 0.8 percent. In 1992 the PCPI of Rutherford was \$15,754 and ranked 54th in the state. The 1992-2002 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the state was 3.8 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Rutherford had a total personal income (TPI) of \$1,396,617*. This TPI ranked 40th in the state and accounted for 0.6 percent of the state total. In 1992 the TPI of Rutherford was \$918,811* and ranked 37th in the state. The 2002 TPI reflected an increase of 0.8 percent from 2001. The 2001-2002 state change was 1.5 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 4.3 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Rutherford. In 2002 net earnings accounted for 61.9 percent of TPI (compared with 67.8 in 1992); dividends, interest, and rent were 14.4 percent (compared with 14.3 in 1992); and personal current transfer receipts were 23.6 percent (compared with 17.9 in 1992). From 2001 to 2002 net earnings decreased 0.8 percent; dividends, interest, and rent decreased 2.9 percent; and personal current transfer receipts increased 7.8 percent. From 1992 to 2002 net earnings increased on average 3.3 percent each year; dividends, interest, and rent increased on average 4.4 percent; and personal current transfer receipts increased on average 7.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Rutherford decreased from \$894,388* in 2001 to \$881,449* in 2002, a decrease of 1.4 percent. The 2001-2002 state change was 1.7 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$656,281* to the 2002 estimate was 3.0 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.4 percent.
