



BEARFACTS 1992 – 2002

Santa Barbara-Santa Maria-Goleta (MSA) [42060]

Santa Barbara-Santa Maria-Goleta is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2002 population of 403,032 ranked 115th in the nation.

PER CAPITA PERSONAL INCOME

In 2002 Santa Barbara-Santa Maria-Goleta had a per capita personal income (PCPI) of \$32,402. This PCPI ranked 53rd in the United States and was 105 percent of the national average, \$30,821. The 2002 PCPI reflected a decrease of 0.7 percent from 2001. The 2001-2002 national change was 0.8 percent. In 1992 the PCPI of Santa Barbara-Santa Maria-Goleta was \$23,988 and ranked 25th in the United States. The 1992-2002 average annual growth rate of PCPI was 3.1 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Santa Barbara-Santa Maria-Goleta had a total personal income (TPI) of \$13,059,171*. This TPI ranked 101st in the United States. In 1992 the TPI of Santa Barbara-Santa Maria-Goleta was \$9,067,632* and ranked 89th in the United States. The 2002 TPI reflected a decrease of 0.4 percent from 2001. The 2001-2002 national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 3.7 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Santa Barbara-Santa Maria-Goleta. In 2002 net earnings accounted for 62.1 percent of TPI (compared with 61.3 in 1992); dividends, interest, and rent were 26.0 percent (compared with 28.0 in 1992); and personal current transfer receipts were 11.9 percent (compared with 10.7 in 1992). From 2001 to 2002 net earnings increased 4.4 percent; dividends, interest, and rent decreased 12.7 percent; and personal current transfer receipts increased 6.9 percent. From 1992 to 2002 net earnings increased on average 3.9 percent each year; dividends, interest, and rent increased on average 2.9 percent; and personal current transfer receipts increased on average 4.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Santa Barbara-Santa Maria-Goleta increased from \$9,073,667* in 2001 to \$9,464,663* in 2002, an increase of 4.3 percent. The 2001-2002 national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$6,397,883* to the 2002 estimate was 4.0 percent. The average annual growth rate for the nation was 5.4 percent.
