



BEARFACTS 1992 – 2002

Hudspeth , Texas [48229]

Hudspeth is one of 254 counties in Texas. It is not part of a Metropolitan Area. Its 2002 population of 3,321 ranked 222nd in the state.

PER CAPITA PERSONAL INCOME

In 2002 Hudspeth had a per capita personal income (PCPI) of \$15,599. This PCPI ranked 241st in the state and was 54 percent of the state average, \$28,835, and 51 percent of the national average, \$30,821. The 2002 PCPI reflected an increase of 8.5 percent from 2001. The 2001-2002 state change was -0.7 percent and the national change was 0.8 percent. In 1992 the PCPI of Hudspeth was \$9,124 and ranked 250th in the state. The 1992-2002 average annual growth rate of PCPI was 5.5 percent. The average annual growth rate for the state was 4.3 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Hudspeth had a total personal income (TPI) of \$51,803*. This TPI ranked 230th in the state and accounted for 0.0 percent of the state total. In 1992 the TPI of Hudspeth was \$26,478* and ranked 244th in the state. The 2002 TPI reflected an increase of 7.3 percent from 2001. The 2001-2002 state change was 1.1 percent and the national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 6.9 percent. The average annual growth rate for the state was 6.4 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Hudspeth. In 2002 net earnings accounted for 62.2 percent of TPI (compared with 60.6 in 1992); dividends, interest, and rent were 14.5 percent (compared with 20.5 in 1992); and personal current transfer receipts were 23.2 percent (compared with 18.9 in 1992). From 2001 to 2002 net earnings increased 10.7 percent; dividends, interest, and rent decreased 7.5 percent; and personal current transfer receipts increased 9.1 percent. From 1992 to 2002 net earnings increased on average 7.2 percent each year; dividends, interest, and rent increased on average 3.3 percent; and personal current transfer receipts increased on average 9.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Hudspeth increased from \$31,202* in 2001 to \$34,681* in 2002, an increase of 11.1 percent. The 2001-2002 state change was 1.0 percent and the national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$17,808* to the 2002 estimate was 6.9 percent. The average annual growth rate for the state was 6.8 percent and for the nation was 5.4 percent.
