



BEARFACTS 1992 – 2002

Panama City-Lynn Haven (BEA-EA) [57123]

Panama City-Lynn Haven is one of 179 BEA Economic Areas in the nation. Its 2002 population of 264,266 ranked 153rd in the nation.

PER CAPITA PERSONAL INCOME

In 2002 Panama City-Lynn Haven had a per capita personal income (PCPI) of \$22,665. This PCPI ranked 161st in the United States and was 74 percent of the national average, \$30,821. The 2002 PCPI reflected an increase of 4.2 percent from 2001. The 2001-2002 national change was 0.8 percent. In 1992 the PCPI of Panama City-Lynn Haven was \$15,576 and ranked 159th in the United States. The 1992-2002 average annual growth rate of PCPI was 3.8 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2002 Panama City-Lynn Haven had a total personal income (TPI) of \$5,989,613*. This TPI ranked 155th in the United States. In 1992 the TPI of Panama City-Lynn Haven was \$3,634,176* and ranked 158th in the United States. The 2002 TPI reflected an increase of 4.1 percent from 2001. The 2001-2002 national change was 1.8 percent. The 1992-2002 average annual growth rate of TPI was 5.1 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Panama City-Lynn Haven. In 2002 net earnings accounted for 59.2 percent of TPI (compared with 62.9 in 1992); dividends, interest, and rent were 17.6 percent (compared with 17.3 in 1992); and personal current transfer receipts were 23.3 percent (compared with 19.8 in 1992). From 2001 to 2002 net earnings increased 6.3 percent; dividends, interest, and rent decreased 6.5 percent; and personal current transfer receipts increased 7.9 percent. From 1992 to 2002 net earnings increased on average 4.5 percent each year; dividends, interest, and rent increased on average 5.3 percent; and personal current transfer receipts increased on average 6.8 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Panama City-Lynn Haven increased from \$3,619,165* in 2001 to \$3,846,216* in 2002, an increase of 6.3 percent. The 2001-2002 national change was 2.1 percent. The average annual growth rate from the 1992 estimate of \$2,476,028* to the 2002 estimate was 4.5 percent. The average annual growth rate for the nation was 5.4 percent.
