



BEARFACTS 1993 – 2003

Neosho , Kansas [20133]

Neosho is one of 105 counties in Kansas. It is not part of a Metropolitan Area. Its 2003 population of 16,453 ranked 33rd in the state.

PER CAPITA PERSONAL INCOME

In 2003 Neosho had a per capita personal income (PCPI) of \$23,601. This PCPI ranked 77th in the state and was 79 percent of the state average, \$29,802, and 75 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 6.6 percent from 2002. The 2002-2003 state change was 2.8 percent and the national change was 2.2 percent. In 1993 the PCPI of Neosho was \$16,977 and ranked 67th in the state. The 1993-2003 average annual growth rate of PCPI was 3.3 percent. The average annual growth rate for the state was 3.9 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Neosho had a total personal income (TPI) of \$388,301*. This TPI ranked 32nd in the state and accounted for 0.5 percent of the state total. In 1993 the TPI of Neosho was \$291,166* and ranked 29th in the state. The 2003 TPI reflected an increase of 5.5 percent from 2002. The 2002-2003 state change was 3.2 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 2.9 percent. The average annual growth rate for the state was 4.6 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Neosho. In 2003 net earnings accounted for 62.9 percent of TPI (compared with 59.8 in 1993); dividends, interest, and rent were 12.8 percent (compared with 18.1 in 1993); and personal current transfer receipts were 24.3 percent (compared with 22.1 in 1993). From 2002 to 2003 net earnings increased 11.4 percent; dividends, interest, and rent decreased 14.5 percent; and personal current transfer receipts increased 4.1 percent. From 1993 to 2003 net earnings increased on average 3.4 percent each year; dividends, interest, and rent decreased on average 0.6 percent; and personal current transfer receipts increased on average 3.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Neosho increased from \$260,843* in 2002 to \$292,062* in 2003, an increase of 12.0 percent. The 2002-2003 state change was 5.0 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$202,435* to the 2003 estimate was 3.7 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.3 percent.
