



BEARFACTS 1993 – 2003 Aitkin , Minnesota [27001]

Aitkin is one of 87 counties in Minnesota. It is not part of a Metropolitan Area. Its 2003 population of 15,658 ranked 56th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Aitkin had a per capita personal income (PCPI) of \$23,207. This PCPI ranked 78th in the state and was 68 percent of the state average, \$34,339, and 74 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 2.2 percent from 2002. The 2002-2003 state change was 3.3 percent and the national change was 2.2 percent. In 1993 the PCPI of Aitkin was \$15,108 and ranked 63rd in the state. The 1993-2003 average annual growth rate of PCPI was 4.4 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Aitkin had a total personal income (TPI) of \$363,371^{*}. This TPI ranked 60th in the state and accounted for 0.2 percent of the state total. In 1993 the TPI of Aitkin was \$198,100^{*} and ranked 61st in the state. The 2003 TPI reflected an increase of 2.9 percent from 2002. The 2002-2003 state change was 3.9 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 6.3 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Aitkin. In 2003 net earnings accounted for 51.6 percent of TPI (compared with 47.4 in 1993); dividends, interest, and rent were 20.7 percent (compared with 23.0 in 1993); and personal current transfer receipts were 27.7 percent (compared with 29.6 in 1993). From 2002 to 2003 net earnings increased 5.4 percent; dividends, interest, and rent decreased 5.3 percent; and personal current transfer receipts increased 4.9 percent. From 1993 to 2003 net earnings increased on average 7.2 percent each year; dividends, interest, and rent increased on average 5.1 percent; and personal current transfer receipts increased on average 5.6 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Aitkin increased from \$150,968^{*} in 2002 to \$163,012^{*} in 2003, an increase of 8.0 percent. The 2002-2003 state change was 4.0 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$85,037^{*} to the 2003 estimate was 6.7 percent. The average annual growth rate for the state was 5.9 percent and for the nation was 5.3 percent.
