



BEARFACTS 1993 – 2003

Naples-Marco Island (MSA) [34940]

Naples-Marco Island is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2003 population of 285,153 ranked 155th in the nation.

PER CAPITA PERSONAL INCOME

In 2003 Naples-Marco Island had a per capita personal income (PCPI) of \$43,095. This PCPI ranked 5th in the United States and was 137 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 2.3 percent from 2002. The 2002-2003 national change was 2.2 percent. In 1993 the PCPI of Naples-Marco Island was \$30,601 and ranked 2nd in the United States. The 1993-2003 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Naples-Marco Island had a total personal income (TPI) of \$12,288,703*. This TPI ranked 110th in the United States. In 1993 the TPI of Naples-Marco Island was \$5,547,513* and ranked 145th in the United States. The 2003 TPI reflected an increase of 5.9 percent from 2002. The 2002-2003 national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 8.3 percent. The average annual growth rate for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Naples-Marco Island. In 2003 net earnings accounted for 41.3 percent of TPI (compared with 40.2 in 1993); dividends, interest, and rent were 48.2 percent (compared with 48.8 in 1993); and personal current transfer receipts were 10.5 percent (compared with 11.1 in 1993). From 2002 to 2003 net earnings increased 11.3 percent; dividends, interest, and rent increased 1.4 percent; and personal current transfer receipts increased 7.0 percent. From 1993 to 2003 net earnings increased on average 8.6 percent each year; dividends, interest, and rent increased on average 8.1 percent; and personal current transfer receipts increased on average 7.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Naples-Marco Island increased from \$5,364,248* in 2002 to \$6,006,228* in 2003, an increase of 12.0 percent. The 2002-2003 national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$2,522,415* to the 2003 estimate was 9.1 percent. The average annual growth rate for the nation was 5.3 percent.
