



BEARFACTS 1993 – 2003

Teton , Wyoming [56039]

Teton is one of 23 counties in Wyoming. It is part of the Jackson, WY-ID Micropolitan SA. Its 2003 population of 18,892 ranked 10th in the state.

PER CAPITA PERSONAL INCOME

In 2003 Teton had a per capita personal income (PCPI) of \$78,484. This PCPI ranked 1st in the state and was 239 percent of the state average, \$32,882, and 249 percent of the national average, \$31,504. The 2003 PCPI reflected an increase of 8.2 percent from 2002. The 2002-2003 state change was 5.7 percent and the national change was 2.2 percent. In 1993 the PCPI of Teton was \$41,584 and ranked 1st in the state. The 1993-2003 average annual growth rate of PCPI was 6.6 percent. The average annual growth rate for the state was 5.1 percent and for the nation was 4.0 percent.

TOTAL PERSONAL INCOME

In 2003 Teton had a total personal income (TPI) of \$1,482,729*. This TPI ranked 3rd in the state and accounted for 9.0 percent of the state total. In 1993 the TPI of Teton was \$571,076* and ranked 5th in the state. The 2003 TPI reflected an increase of 9.1 percent from 2002. The 2002-2003 state change was 6.2 percent and the national change was 3.1 percent. The 1993-2003 average annual growth rate of TPI was 10.0 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.1 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Teton. In 2003 net earnings accounted for 45.6 percent of TPI (compared with 59.4 in 1993); dividends, interest, and rent were 51.0 percent (compared with 36.0 in 1993); and personal current transfer receipts were 3.4 percent (compared with 4.7 in 1993). From 2002 to 2003 net earnings increased 2.4 percent; dividends, interest, and rent increased 16.1 percent; and personal current transfer receipts increased 7.5 percent. From 1993 to 2003 net earnings increased on average 7.1 percent each year; dividends, interest, and rent increased on average 13.9 percent; and personal current transfer receipts increased on average 6.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Teton increased from \$826,187* in 2002 to \$843,479* in 2003, an increase of 2.1 percent. The 2002-2003 state change was 5.1 percent and the national change was 3.8 percent. The average annual growth rate from the 1993 estimate of \$412,598* to the 2003 estimate was 7.4 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.3 percent.
