



BEARFACTS 1994 – 2004

Vallejo-Fairfield (MSA) [46700]

Vallejo-Fairfield is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2004 population of 409,671 ranked 112th in the nation.

PER CAPITA PERSONAL INCOME

In 2004 Vallejo-Fairfield had a per capita personal income (PCPI) of \$31,955. This PCPI ranked 106th in the United States and was 96 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 5.4 percent from 2003. The 2003-2004 national change was 5.1 percent. In 1994 the PCPI of Vallejo-Fairfield was \$20,541 and ranked 145th in the United States. The 1994-2004 average annual growth rate of PCPI was 4.5 percent. The average annual growth rate for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Vallejo-Fairfield had a total personal income (TPI) of \$13,091,216*. This TPI ranked 109th in the United States. In 1994 the TPI of Vallejo-Fairfield was \$7,519,411* and ranked 118th in the United States. The 2004 TPI reflected an increase of 5.5 percent from 2003. The 2003-2004 national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 5.7 percent. The average annual growth rate for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Vallejo-Fairfield. In 2004 net earnings accounted for 75.2 percent of TPI (compared with 73.3 in 1994); dividends, interest, and rent were 12.2 percent (compared with 14.6 in 1994); and personal current transfer receipts were 12.6 percent (compared with 12.0 in 1994). From 2003 to 2004 net earnings increased 6.4 percent; dividends, interest, and rent increased 1.2 percent; and personal current transfer receipts increased 4.6 percent. From 1994 to 2004 net earnings increased on average 6.0 percent each year; dividends, interest, and rent increased on average 3.8 percent; and personal current transfer receipts increased on average 6.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Vallejo-Fairfield increased from \$6,960,615* in 2003 to \$7,489,429* in 2004, an increase of 7.6 percent. The 2003-2004 national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$4,199,173* to the 2004 estimate was 6.0 percent. The average annual growth rate for the nation was 5.5 percent.
