



BEARFACTS 1994 – 2004 Ozaukee , Wisconsin [55089]

Ozaukee is one of 72 counties in Wisconsin. It is part of the [Milwaukee-Waukesha-West Allis, WI \(MSA\)](#). Its 2004 population of 85,006 ranked 18th in the state.

PER CAPITA PERSONAL INCOME

In 2004 Ozaukee had a per capita personal income (PCPI) of \$50,693. This PCPI ranked 1st in the state and was 160 percent of the state average, \$31,697, and 153 percent of the national average, \$33,123. The 2004 PCPI reflected an increase of 5.5 percent from 2003. The 2003-2004 state change was 3.2 percent and the national change was 5.1 percent. In 1994 the PCPI of Ozaukee was \$31,634 and ranked 1st in the state. The 1994-2004 average annual growth rate of PCPI was 4.8 percent. The average annual growth rate for the state was 4.0 percent and for the nation was 4.1 percent.

TOTAL PERSONAL INCOME

In 2004 Ozaukee had a total personal income (TPI) of \$4,309,199*. This TPI ranked 11th in the state and accounted for 2.5 percent of the state total. In 1994 the TPI of Ozaukee was \$2,474,160* and ranked 11th in the state. The 2004 TPI reflected an increase of 6.4 percent from 2003. The 2003-2004 state change was 3.9 percent and the national change was 6.1 percent. The 1994-2004 average annual growth rate of TPI was 5.7 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 5.2 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Ozaukee. In 2004 net earnings accounted for 68.2 percent of TPI (compared with 70.4 in 1994); dividends, interest, and rent were 24.4 percent (compared with 22.8 in 1994); and personal current transfer receipts were 7.3 percent (compared with 6.8 in 1994). From 2003 to 2004 net earnings increased 4.8 percent; dividends, interest, and rent increased 12.3 percent; and personal current transfer receipts increased 2.7 percent. From 1994 to 2004 net earnings increased on average 5.4 percent each year; dividends, interest, and rent increased on average 6.5 percent; and personal current transfer receipts increased on average 6.5 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Ozaukee increased from \$1,912,532* in 2003 to \$2,046,292* in 2004, an increase of 7.0 percent. The 2003-2004 state change was 4.7 percent and the national change was 6.5 percent. The average annual growth rate from the 1994 estimate of \$1,176,839* to the 2004 estimate was 5.7 percent. The average annual growth rate for the state was 4.9 percent and for the nation was 5.5 percent.
