



BEARFACTS 1995 – 2005 Tuolumne , California [06109]

Tuolumne is one of 58 counties in California. It is part of the Phoenix Lake-Cedar Ridge, CA Micropolitan SA. Its 2005 population of 56,295 ranked 42nd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Tuolumne had a per capita personal income (PCPI) of \$29,119. This PCPI ranked 29th in the state and was 78 percent of the state average, \$37,462, and 84 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 5.1 percent from 2004. The 2004-2005 state change was 5.7 percent and the national change was 4.9 percent. In 1995 the PCPI of Tuolumne was \$17,989 and ranked 42nd in the state. The 1995-2005 average annual growth rate of PCPI was 4.9 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Tuolumne had a total personal income (TPI) of \$1,639,251*. This TPI ranked 41st in the state and accounted for 0.1 percent of the state total. In 1995 the TPI of Tuolumne was \$932,049* and ranked 40th in the state. The 2005 TPI reflected an increase of 5.3 percent from 2004. The 2004-2005 state change was 6.5 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 5.8 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Tuolumne. In 2005 net earnings accounted for 57.4 percent of TPI (compared with 52.1 in 1995); dividends, interest, and rent were 21.4 percent (compared with 25.6 in 1995); and personal current transfer receipts were 21.3 percent (compared with 22.4 in 1995). From 2004 to 2005 net earnings increased 8.2 percent; dividends, interest, and rent decreased 1.5 percent; and personal current transfer receipts increased 5.0 percent. From 1995 to 2005 net earnings increased on average 6.8 percent each year; dividends, interest, and rent increased on average 3.9 percent; and personal current transfer receipts increased on average 5.3 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Tuolumne increased from \$862,004* in 2004 to \$935,997* in 2005, an increase of 8.6 percent. The 2004-2005 state change was 5.8 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$491,671* to the 2005 estimate was 6.6 percent. The average annual growth rate for the state was 6.2 percent and for the nation was 5.5 percent.
