



BEARFACTS 1995 – 2005

Blackford , Indiana [18009]

Blackford is one of 92 counties in Indiana. It is not part of a Metropolitan Area. Its 2005 population of 13,520 ranked 84th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Blackford had a per capita personal income (PCPI) of \$23,634. This PCPI ranked 84th in the state and was 76 percent of the state average, \$30,900, and 68 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 2.8 percent from 2004. The 2004-2005 state change was 3.2 percent and the national change was 4.9 percent. In 1995 the PCPI of Blackford was \$16,962 and ranked 81st in the state. The 1995-2005 average annual growth rate of PCPI was 3.4 percent. The average annual growth rate for the state was 3.7 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Blackford had a total personal income (TPI) of \$319,529*. This TPI ranked 84th in the state and accounted for 0.2 percent of the state total. In 1995 the TPI of Blackford was \$239,617* and ranked 84th in the state. The 2005 TPI reflected an increase of 2.2 percent from 2004. The 2004-2005 state change was 3.8 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 2.9 percent. The average annual growth rate for the state was 4.4 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Blackford. In 2005 net earnings accounted for 62.3 percent of TPI (compared with 64.3 in 1995); dividends, interest, and rent were 13.5 percent (compared with 16.3 in 1995); and personal current transfer receipts were 24.2 percent (compared with 19.4 in 1995). From 2004 to 2005 net earnings increased 1.2 percent; dividends, interest, and rent decreased 2.4 percent; and personal current transfer receipts increased 7.7 percent. From 1995 to 2005 net earnings increased on average 2.6 percent each year; dividends, interest, and rent increased on average 1.0 percent; and personal current transfer receipts increased on average 5.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Blackford increased from \$167,698* in 2004 to \$169,773* in 2005, an increase of 1.2 percent. The 2004-2005 state change was 3.2 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$126,071* to the 2005 estimate was 3.0 percent. The average annual growth rate for the state was 4.5 percent and for the nation was 5.5 percent.
