



BEARFACTS 1995 – 2005

Park , Montana [30067]

Park is one of 56 counties in Montana. It is not part of a Metropolitan Area. Its 2005 population of 15,769 ranked 12th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Park had a per capita personal income (PCPI) of \$27,910. This PCPI ranked 24th in the state and was 96 percent of the state average, \$29,183, and 80 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 7.4 percent from 2004. The 2004-2005 state change was 4.8 percent and the national change was 4.9 percent. In 1995 the PCPI of Park was \$17,260 and ranked 22nd in the state. The 1995-2005 average annual growth rate of PCPI was 4.9 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Park had a total personal income (TPI) of \$440,117*. This TPI ranked 11th in the state and accounted for 1.6 percent of the state total. In 1995 the TPI of Park was \$271,395* and ranked 11th in the state. The 2005 TPI reflected an increase of 8.4 percent from 2004. The 2004-2005 state change was 5.8 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 5.0 percent. The average annual growth rate for the state was 5.4 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Park. In 2005 net earnings accounted for 60.2 percent of TPI (compared with 56.5 in 1995); dividends, interest, and rent were 23.0 percent (compared with 24.7 in 1995); and personal current transfer receipts were 16.7 percent (compared with 18.8 in 1995). From 2004 to 2005 net earnings increased 10.0 percent; dividends, interest, and rent increased 7.4 percent; and personal current transfer receipts increased 4.3 percent. From 1995 to 2005 net earnings increased on average 5.6 percent each year; dividends, interest, and rent increased on average 4.2 percent; and personal current transfer receipts increased on average 3.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Park increased from \$210,443* in 2004 to \$232,318* in 2005, an increase of 10.4 percent. The 2004-2005 state change was 7.6 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$159,728* to the 2005 estimate was 3.8 percent. The average annual growth rate for the state was 5.8 percent and for the nation was 5.5 percent.
