



## **BEARFACTS 1995 – 2005**

### **Keith , Nebraska [31101]**

Keith is one of 93 counties in Nebraska. It is not part of a Metropolitan Area. Its 2005 population of 8,130 ranked 37th in the state.

#### **PER CAPITA PERSONAL INCOME**

In 2005 Keith had a per capita personal income (PCPI) of \$25,123. This PCPI ranked 67th in the state and was 76 percent of the state average, \$32,882, and 72 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 0.8 percent from 2004. The 2004-2005 state change was 3.5 percent and the national change was 4.9 percent. In 1995 the PCPI of Keith was \$17,791 and ranked 56th in the state. The 1995-2005 average annual growth rate of PCPI was 3.5 percent. The average annual growth rate for the state was 4.2 percent and for the nation was 4.2 percent.

#### **TOTAL PERSONAL INCOME**

In 2005 Keith had a total personal income (TPI) of \$204,247\*. This TPI ranked 39th in the state and accounted for 0.4 percent of the state total. In 1995 the TPI of Keith was \$155,547\* and ranked 37th in the state. The 2005 TPI reflected a decrease of 0.2 percent from 2004. The 2004-2005 state change was 4.1 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 2.8 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 5.3 percent.

#### **COMPONENTS OF TOTAL PERSONAL INCOME**

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Keith. In 2005 net earnings accounted for 59.0 percent of TPI (compared with 57.1 in 1995); dividends, interest, and rent were 18.9 percent (compared with 25.4 in 1995); and personal current transfer receipts were 22.1 percent (compared with 17.5 in 1995). From 2004 to 2005 net earnings increased 3.2 percent; dividends, interest, and rent decreased 13.9 percent; and personal current transfer receipts increased 4.8 percent. From 1995 to 2005 net earnings increased on average 3.1 percent each year; dividends, interest, and rent decreased on average 0.2 percent; and personal current transfer receipts increased on average 5.2 percent.

#### **EARNINGS BY PLACE OF WORK**

Earnings of persons employed in Keith increased from \$123,190\* in 2004 to \$126,768\* in 2005, an increase of 2.9 percent. The 2004-2005 state change was 3.6 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$95,401\* to the 2005 estimate was 2.9 percent. The average annual growth rate for the state was 5.0 percent and for the nation was 5.5 percent.
