



BEARFACTS 1995 – 2005

Ellis , Oklahoma [40045]

Ellis is one of 77 counties in Oklahoma. It is not part of a Metropolitan Area. Its 2005 population of 3,881 ranked 73rd in the state.

PER CAPITA PERSONAL INCOME

In 2005 Ellis had a per capita personal income (PCPI) of \$24,839. This PCPI ranked 30th in the state and was 83 percent of the state average, \$30,107, and 71 percent of the national average, \$34,757. The 2005 PCPI remained unchanged from 2004. The 2004-2005 state change was 5.8 percent and the national change was 4.9 percent. In 1995 the PCPI of Ellis was \$16,786 and ranked 20th in the state. The 1995-2005 average annual growth rate of PCPI was 4.0 percent. The average annual growth rate for the state was 4.8 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Ellis had a total personal income (TPI) of \$96,400*. This TPI ranked 74th in the state and accounted for 0.1 percent of the state total. In 1995 the TPI of Ellis was \$70,132* and ranked 74th in the state. The 2005 TPI reflected a decrease of 0.9 percent from 2004. The 2004-2005 state change was 6.4 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 3.2 percent. The average annual growth rate for the state was 5.5 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Ellis. In 2005 net earnings accounted for 58.9 percent of TPI (compared with 47.0 in 1995); dividends, interest, and rent were 17.6 percent (compared with 30.5 in 1995); and personal current transfer receipts were 23.5 percent (compared with 22.4 in 1995). From 2004 to 2005 net earnings increased 7.6 percent; dividends, interest, and rent decreased 22.7 percent; and personal current transfer receipts increased 0.5 percent. From 1995 to 2005 net earnings increased on average 5.6 percent each year; dividends, interest, and rent decreased on average 2.3 percent; and personal current transfer receipts increased on average 3.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Ellis increased from \$44,514* in 2004 to \$46,901* in 2005, an increase of 5.4 percent. The 2004-2005 state change was 6.4 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$30,805* to the 2005 estimate was 4.3 percent. The average annual growth rate for the state was 5.7 percent and for the nation was 5.5 percent.
