



BEARFACTS 1995 – 2005

Crane , Texas [48103]

Crane is one of 254 counties in Texas. It is not part of a Metropolitan Area. Its 2005 population of 3,758 ranked 214th in the state.

PER CAPITA PERSONAL INCOME

In 2005 Crane had a per capita personal income (PCPI) of \$23,759. This PCPI ranked 177th in the state and was 71 percent of the state average, \$33,253, and 68 percent of the national average, \$34,757. The 2005 PCPI reflected an increase of 11.4 percent from 2004. The 2004-2005 state change was 7.4 percent and the national change was 4.9 percent. In 1995 the PCPI of Crane was \$16,610 and ranked 138th in the state. The 1995-2005 average annual growth rate of PCPI was 3.6 percent. The average annual growth rate for the state was 4.7 percent and for the nation was 4.2 percent.

TOTAL PERSONAL INCOME

In 2005 Crane had a total personal income (TPI) of \$89,288*. This TPI ranked 218th in the state and accounted for 0.0 percent of the state total. In 1995 the TPI of Crane was \$72,056* and ranked 210th in the state. The 2005 TPI reflected an increase of 9.8 percent from 2004. The 2004-2005 state change was 9.3 percent and the national change was 5.9 percent. The 1995-2005 average annual growth rate of TPI was 2.2 percent. The average annual growth rate for the state was 6.7 percent and for the nation was 5.3 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Crane. In 2005 net earnings accounted for 70.4 percent of TPI (compared with 68.6 in 1995); dividends, interest, and rent were 10.1 percent (compared with 14.9 in 1995); and personal current transfer receipts were 19.5 percent (compared with 16.4 in 1995). From 2004 to 2005 net earnings increased 12.5 percent; dividends, interest, and rent increased 0.4 percent; and personal current transfer receipts increased 5.9 percent. From 1995 to 2005 net earnings increased on average 2.4 percent each year; dividends, interest, and rent decreased on average 1.7 percent; and personal current transfer receipts increased on average 3.9 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Crane increased from \$67,317* in 2004 to \$75,629* in 2005, an increase of 12.3 percent. The 2004-2005 state change was 7.6 percent and the national change was 5.4 percent. The average annual growth rate from the 1995 estimate of \$64,167* to the 2005 estimate was 1.7 percent. The average annual growth rate for the state was 6.9 percent and for the nation was 5.5 percent.
