



BEARFACTS 1996 – 2006

Bradenton-Sarasota-Venice (MSA) [14600]

Bradenton-Sarasota-Venice is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2006 population of 680,500 ranked 74th in the nation.

PER CAPITA PERSONAL INCOME

In 2006 Bradenton-Sarasota-Venice had a per capita personal income (PCPI) of \$46,486. This PCPI ranked 13th in the United States and was 127 percent of the national average, \$36,714. The 2006 PCPI reflected an increase of 6.4 percent from 2005. The 2005-2006 national change was 5.6 percent. In 1996 the PCPI of Bradenton-Sarasota-Venice was \$28,964 and ranked 16th in the United States. The 1996-2006 average annual growth rate of PCPI was 4.8 percent. The average annual growth rate for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Bradenton-Sarasota-Venice had a total personal income (TPI) of \$31,633,885*. This TPI ranked 59th in the United States. In 1996 the TPI of Bradenton-Sarasota-Venice was \$15,959,120* and ranked 64th in the United States. The 2006 TPI reflected an increase of 8.2 percent from 2005. The 2005-2006 national change was 6.7 percent. The 1996-2006 average annual growth rate of TPI was 7.1 percent. The average annual growth rate for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Bradenton-Sarasota-Venice. In 2006 net earnings accounted for 46.0 percent of TPI (compared with 44.7 in 1996); dividends, interest, and rent were 39.4 percent (compared with 38.7 in 1996); and personal current transfer receipts were 14.6 percent (compared with 16.6 in 1996). From 2005 to 2006 net earnings increased 6.3 percent; dividends, interest, and rent increased 10.6 percent; and personal current transfer receipts increased 8.0 percent. From 1996 to 2006 net earnings increased on average 7.4 percent each year; dividends, interest, and rent increased on average 7.3 percent; and personal current transfer receipts increased on average 5.7 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Bradenton-Sarasota-Venice increased from \$14,570,384* in 2005 to \$15,664,291* in 2006, an increase of 7.5 percent. The 2005-2006 national change was 5.7 percent. The average annual growth rate from the 1996 estimate of \$7,599,679* to the 2006 estimate was 7.5 percent. The average annual growth rate for the nation was 5.5 percent.
