



BEARFACTS 1996 – 2006

Florence-Muscle Shoals (MSA) [22520]

Florence-Muscle Shoals is one of 363 Metropolitan Statistical Areas (MSAs) in the nation. Its 2006 population of 142,539 ranked 268th in the nation.

PER CAPITA PERSONAL INCOME

In 2006 Florence-Muscle Shoals had a per capita personal income (PCPI) of \$27,025. This PCPI ranked 321st in the United States and was 74 percent of the national average, \$36,714. The 2006 PCPI reflected an increase of 5.0 percent from 2005. The 2005-2006 national change was 5.6 percent. In 1996 the PCPI of Florence-Muscle Shoals was \$19,636 and ranked 276th in the United States. The 1996-2006 average annual growth rate of PCPI was 3.2 percent. The average annual growth rate for the nation was 4.3 percent.

TOTAL PERSONAL INCOME

In 2006 Florence-Muscle Shoals had a total personal income (TPI) of \$3,852,047*. This TPI ranked 283rd in the United States. In 1996 the TPI of Florence-Muscle Shoals was \$2,755,325* and ranked 259th in the United States. The 2006 TPI reflected an increase of 5.5 percent from 2005. The 2005-2006 national change was 6.7 percent. The 1996-2006 average annual growth rate of TPI was 3.4 percent. The average annual growth rate for the nation was 5.4 percent.

COMPONENTS OF TOTAL PERSONAL INCOME

Total personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Florence-Muscle Shoals. In 2006 net earnings accounted for 60.7 percent of TPI (compared with 64.4 in 1996); dividends, interest, and rent were 15.8 percent (compared with 17.7 in 1996); and personal current transfer receipts were 23.5 percent (compared with 17.9 in 1996). From 2005 to 2006 net earnings increased 4.2 percent; dividends, interest, and rent increased 7.1 percent; and personal current transfer receipts increased 7.5 percent. From 1996 to 2006 net earnings increased on average 2.8 percent each year; dividends, interest, and rent increased on average 2.3 percent; and personal current transfer receipts increased on average 6.2 percent.

EARNINGS BY PLACE OF WORK

Earnings of persons employed in Florence-Muscle Shoals increased from \$2,305,628* in 2005 to \$2,398,599* in 2006, an increase of 4.0 percent. The 2005-2006 national change was 5.7 percent. The average annual growth rate from the 1996 estimate of \$1,869,403* to the 2006 estimate was 2.5 percent. The average annual growth rate for the nation was 5.5 percent.
